INFORMATION ON DATA TREATMENT AND CONSENT OF THE USE OF AUDIO-VISUAL IMAGES AND PHOTOGRAPHS

I the undersigned declare that I have been specifically informed of the fact that, by means of the uploading of the audio-visual material containing my artistic interpretation of the monologues, photographs, autobiographical information (hereinafter referred to as the "Material") visible to Indyca s.r.l., with legal offices at Corso San Martino 4, 10122 Turin (IT), I have access to participating in the casting for a role in the film temporarily entitled "Samia", produced by Indyca s.r.l. together with the German company S2R as well as any other co-producers that might in future be involved.

By means of said uploading, consequently, I specifically agree that:

- the Material may be viewed by Indyca and by same transmitted to S2R, Rai Cinema, to the director of the Film and the screenwriters as well as to those persons who collaborate or who will collaborate in realizing the Film;
- the Material may be utilized in any form that Indyca deems useful or necessary solely for the purposes of casting for the Film indicated and for no other purpose.

In addition, I declare that I have been specifically informed that:

- the Data Controller of personal data is Indyca s.r.l. at its legal offices at Corso San Martino 4, Turin, in the person of the legal representative Mr. Michele Fornasero. The personal data provided by me will be treated in compliance with the general principles of transparency, correctness and confidentiality;
- the personal data that I voluntarily provided consists of contact information, registry information, images of myself;
- I the undersigned declare that I have been duly informed of the fact that the data provided will be treated:
 - a) for the execution of the contractual agreements undertaken, that is for the purposes of casting. The conferral of the data for those purposes is obligatory inasmuch as refusal to do so would imply the impossibility of complying with the contractual obligations undertaken and consequently the impossibility for the interested party to participate in the casting. The juridical basis that legitimizes the treatment is the execution of a contract in which the interested person is a party thereto;
 - b) for administrative purposes and to comply with legal obligations such as those relating to tax or accounting obligations or in order to respond to requests from judicial authorities. The juridical basis is compliance with a legal obligation;
 - c) subject to specific and express consent in that sense in order for Indyca s.r.l. to send communications relating to events, showings, shows. Conferral of the data is discretionary but any refusal to do so will entail the impossibility of receiving information relating to activities organized by Indyca s.r.l.. The juridical basis is the consent freely given by the interested party.
- Data will be treated using hard copies and electronic copies, in compliance with current regulations and by EU Regulation 679/2016, guaranteeing the security, integrity and confidentiality of the personal data. The Data Controller adopts all reasonable measures in order to guarantee the correctness of the data.
- Data will be stored for the time strictly needed to manage the purposes for which said data has been collected in compliance with current regulations and laws, generally for the entire duration of the author's rights. In any case Indyca s.r.l. avoids treating data for undetermined lengths of time and adheres to the principle of minimizing data treatment.
- Treatment of personal data takes place under the control of Indyca s.r.l. Treatment is carried out by the controller and/or by persons so authorized under the direct authority of the controller. Data collected will not be utilized for profiling of any nature.
- Without prejudice obligatory communications to third parties pursuant to law to comply with administrative, accounting and tax matters, the data may be communicated to banking institutions,

insurance companies, professional third-party consultants (such as but not limited to accountants, legal consultants, labor consultants).

- For the same purposes envisaged in paragraphs a) and b) data may be communicated to any of Indyca's eligible parties such as co-producers, financiers, executive producers, distributors, festivals or third parties that take part in the realization or in the distribution of the Film, also outside the European Economic Area to Indyca s.r.l.'s eligible parties adopting appropriate measures to ensure that the recipients adequately protect the personal data.
- The recipients may treat my personal data in order to manage the rights subject to this contract and may utilize my personal data to contact me or to establish the rights granted by me in this document. Said data treatment has a juridical basis in the contract undersigned by me with the Producer and consequently consent to this type of treatment by the Producer's eligible third parties is obligatory in order to execute the contract stipulated; the recipients will not store the personal information for a period of time longer than that required for said purposes, which generally will be the period of safeguarding the author's rights granted by me in this document.
- None of my personal data will be disclosed.
- Pursuant to current regulations and Section 13 of EU Regulation 679/2016, I the undersigned moreover am entitled to:
 - obtain from Indyca s.r.l. access to the personal data that concerns me, confirmation or denial that same exists, even if not yet registered and their communication in an intelligible manner;
 - obtain the updating, correction and integration of the data, the cancellation, the transformation in an anonymous format or the blockage of the data treated in violation of the law, to obtain the declaration that the preceding operations were made known, also with respect to their content, to those to whom the data was communicated or disclosed;
 - obtain the portability of the data;
 - object for legitimate reasons to the treatment of the personal data that concerns me, save cases of obligatory treatment of data specifically envisaged by current regulations;
 - submit a complaint to the competent supervisory authorities (Garante per la Protezione dei Dati Personali, Italian Data Protection Authority), which can be contacted through the following internet address: www.garanteprivacy.it
 - consent to the treatment set forth in the above-mentioned paragraph c) may be revoked at any time without prejudicing the legality of the treatment based on the consent given prior to the revocation.
